
## FROM THE BOARD ROOM

Dear BCS District Residents,

It has been a very productive year for our School District and the future looks bright.

We made great progress towards the District goals adopted for the years 2018-2023, so it was time to update the goals for the next few years. Details can be found on the school website. You will notice that the focus of the new goals has concentrated even more on different aspects of student learning and performance:

- Increase student engagement in the learning process
- · Improve literacy for all learners
- · Improve instructional outcomes for all students



Our financial condition has improved significantly over the past several years. This is due in part to careful budgeting and spending and long-term planning. In recent years, we have also seen significant increases in state aid which are very helpful after many years of inadequate funding resulting from the closure of the power plant.


As you may know, construction has begun on a \$25 million capital project that is being paid for with reserve funds and state financial support. This major project will impact our students and community in many positive ways for years to come.

Over the past year we made a very thoughtful transition in our sports identity from the Barker Raiders to the Barker Bulldogs. (A change was required by state law.) Student and community input was sought along the way and the new mascot adopted recently was based on a student drawing selected from many inspired designs.

The budget we are presenting for your consideration represents an increase in spending of 3.85% over the current year for a total of \$18,895,718. This amount will support continuation of all current programs. Several new courses are also being offered with virtually no budget impact. The local school tax levy is projected to increase 2.8% for a total of \$5,157,400. While we are anticipating another significant increase in state aid, we need a modest increase in local taxes to move towards a long-term sustainable budget. As you may know, we are getting some supplemental state support from the Energy Cessation Mitigation Fund, but this decreases each year and will expire completely in another four years. More details about the budget will be found in this edition of the Banner.

By nature, education is focused on the future. Our staff, administration and school board are constantly planning for the short and long-term future of our District. We have much to look forward to and appreciate your support.

# A MESSAGE FROM YOUR SUPERINTENDENT

Dear Barker Learning Community,

I hope this edition of *The Banner* finds you all well and getting ready for the upcoming summer months. As always, we have a lot going on around campus and I hope you have a chance to see all the great things our students are doing, both in and out of the classroom here in Barker.

If you have been on campus this spring, I am sure you have seen all the construction happening. Phase 1 of the project approved by voters in December, 2022 is fully

underway and currently right on schedule. The items currently under construction, including the parking lot renovation and reconfiguration, the multipurpose field, tennis courts, boilers, and some window work is set to be done on time by the start of school in the fall. Be on the lookout for scheduled events with the new multipurpose field, including some football games, soccer, and field hockey this fall. We will be having some night games and we hope to see you all there enjoying the new facilities and watching our student athletes compete.

Our parking lots are a significant portion of the improvements being made with this project. Virtually all the parking lots in the District are being renovated to some degree and there will be some significant changes to how the traffic flow will be occurring around the building. The biggest change will be how parking and traffic work in front of the 1911 building and in front of the building along Haight Road. As we get closer to school starting, please check the District website for more information on how these new traffic patterns will flow to make the first days of school as seamless as possible.

We are still waiting on the final Department of Education review of Phase 2 of the project. We hope to begin construction on that work, which includes all the interior work of creating a single point of entry to District buildings, renovating our technology instruction area, Family and Consumer Sciences, Library Media Center, and a number of classrooms to name a few, starting in the fall with a full completion by October 2025. We hope to get it all done prior to the start of the 2025-26 school year, but it may take a little longer to complete.

Our transportation services will be changing a little this fall too. The only thing you will probably notice is that our large busses will be much quieter than they have been in the past. As you may recall, the District, in partnership with Student Transportation of America, our transportation provider, secured grant funding to replace 12 of our current large capacity busses with electric busses. These busses look no different than our current busses from the outside, but you will surely hear a difference without the guttural sound of a diesel engine. Just about the only thing you can hear from these busses is the sound of the tires rolling over the pavement, and not much more. We expect these busses to be in services at some point before the snow flies, but we are not sure quite when they will be rolling exactly.

These are just a few of the new and exciting things going on and I can't wait to see where we go next with everything that is happening for our students and larger community.

Lastly, please don't forget to vote on the District budget, Board seats, and the Barker Public Library propositions on Tuesday, May 21, 2024 in the Ludwig Auditorium between noon and 8 pm!

Dear Barker Central School Community,

This school year is flying by so quickly! There have been so many amazing things going on at Barker this year. As we head into the last few weeks of school, there are some important dates and information that we would like to share with you.

PreK registration is now open for students who are 4 years old or will be turning 4 before December 1, 2024. You can find all of the registration information on our website. Our program is full-day, from 7:50 am to 2:30 pm. Placement is not

guaranteed and spots will go to District residents before non-resident students. Bussing is available for all students who are District residents. Please share this information with any families you know who have a child eligible for PreK this year. Please contact Rachel Anderson at (716) 795-3237 for any assistance in the registration process for students of all grade levels.

Moving Up Day for Pratt Elementary will take place on Friday, June 21, 2024, which will be the last day of school for elementary students. More information regarding the specific details of the event will be shared as we get closer to the end of the school year. The last day of school for the 7-12 students will be on Thursday, June 13, 2024. Jr.-Sr. High students are expected to return to school to take their Regents exams during the last few weeks of June. The official dates and times for students to report will be forthcoming. The end of school year dates are subject to change based on any official changes to the school calendar. If this occurs, then information will be sent home to families. Commencement this year will take place on Friday, June 28, 2024, at 7:00 pm to celebrate the successes of the Class of 2024.

Similar to last year, we will first be running our District-wide summer school program for students in grades PreK-8, and second credit recovery for students in grades 9-12. The program will begin with students on Tuesday, July 2<sup>nd</sup>, and end on Thursday, August 1<sup>st</sup>. Students will be invited to participate in the program based on academic need with recommendation from their teachers. The PreK-8 program will include academic support in ELA and math and extracurricular enrichment opportunities in STEM experiences, P.E. and swim programming, and art activities.

Please save the date for Wednesday, August 28, 2024, from 5:30 to 7:00 pm for the Grades 1-12 Welcome Back Night/Open House event. The PreK/K students will have a separate Welcome Back Day on Thursday, August, 29, 2024 from 1:00 to 2:30 pm. The first day of school for all students will be on Tuesday, September 3, 2024.

# FROM THE DESK OF MR. CARTER

Hello Barker Learning Community. We are quickly approaching our annual budget vote. This article contains some information regarding the 2024-2025 budget.

Our goals with this budget are to:

- 1. Ensure the long-term fiscal health of the District by building revenues and reserves for future funding gaps
- 2. Continue to fund all current programming
- 3. Continue social-emotional supports for our students



The local property tax levy will be \$5,157,400, which is an increase of 3.8% from the current year. Local property taxes account for only about 27% of our revenue; we are very dependent on New York State Aid for the vast majority of our income. However, districts have very little control over the amount of funding we receive from New York State.

We encourage District residents who wish to learn more about the budget to attend the public hearing on Monday, May 13, 2024 at 6:30 pm in the high school auditorium. The annual vote will be held on Tuesday, May 21, 2024 from Noon to 8:00 pm in the auditorium.

# FROM THE DESK OF MR. LEARO

Dear Barker School Community,

My first few months have been busy, productive and exciting. I've had the wonderful opportunity to meet many of you and look forward to continuing to immerse myself in the Barker community. Please feel free to contact me with any questions or comments regarding Instructional and Special Education services at mlearo@barkercsd.net or (716) 795-3350.

As we approach the close of the 2023-2024 school year I would like to share some important information regarding Special Education:

Special education programs and services provide equity and access for students with disabilities to be involved in and to participate and progress in the general education curriculum. The New York State Education Department has established a blueprint for Improved Results for Students with Disabilities. This statewide framework is intended to help guide improvement of instruction to prepare students for success beginning in the preschool years and to lay the foundation for post-secondary readiness and success.

- 1. Students engage in self-advocacy and are involved in determining their own education goals and plans (Students participate in IEP meetings, monitor their progress towards academic & social goals, engage in career planning and selection of courses of study).
- 2. Parents, and other family members, are engaged as meaningful partners in the special education process and the education of their child (Parents understand what their child is expected to know, engage in frequent, respectful, and open conversation about the educational needs of their child with school staff and have the information they need about effective strategies to support their child's learning).
- 3. Teachers design, provide, and assess the effectiveness of specially designed instruction to provide students with disabilities with access to participate and progress in the general education curriculum (This is evident when IEPs are developed in consideration of grade level standards and are implemented and reviewed by educators, families and students to ensure that students are meeting their annual goals, students with disabilities receive instructional materials in alternative formats as necessary).
- 4. Teachers provide research-based instructional teaching and learning strategies and supports for students with disabilities (This is evident when teachers develop lessons that allow multiple entry points and multiple

modes of engagement for students with diverse needs, teachers assess students' understanding of lessons to improve and target instruction to student needs).

- 5. Schools provide multi-tiered systems of behavioral and academic support.
- 6. Schools provide high quality inclusive programs and activities.
- Schools provide appropriate instruction for students with disabilities in career development and opportunities to participate in work-based learning.

Here at Barker we strive to educate all students to reach their fullest potential and experience success. I have been impressed by the dedication, hard work, and commitment of the entire Barker School Community in educating and supporting all of our students and their needs.


The Professional Development Days held on March 8<sup>th</sup> and April 8<sup>th</sup> for our teachers and staff were a success. Feedback from the teachers and staff who participated was very favorable. The primary focus of both days was moving the work in our District strategic plan forward. As a reminder our three main goals within this plan are:



- 1. Increase Student Engagement in the Learning Process: Through a collaborative process, stakeholders will be empowered to improve student engagement in the learning process through continual improvement.
- 2. Improve Literacy for all Learners to be prepared for the 21st Century: Through a collaborative process, stakeholders will create an environment that supports increased student literacy including reading, writing, comprehension, and communication in all forms.
- 3. Improve Instructional Outcomes for all Students: To sustain and expand student academic success by collaboratively reviewing data and developing data-driven processes which continuously foster improvements in instructional areas that impact student learning and achievement.

A specific focus during these days was on goal #3 and the collaborative effort of reviewing data and developing data-driven processes that emphasize continuous improvement in student learning.

In addition to the above, over the past year and a half, our teachers have been working on a program to "map out" their curriculum and instruction over the entire school years' time. As part of this work, grade level and content area teachers are developing a sequential plan that indicates the order in which content will be taught and learned, as well as the in-depth planning of instructional units of study. While this work is ongoing and continuous, our goal is to have the vast majority of this work completed prior to the start of the 2024-2025 school year.

# WASHINGTON, D.C.

March 25-28, 2024 a group of students from the Class of 2028 traveled to Gettysburg, Pennsylvania and Washington, D.C. for the annual 8<sup>th</sup> grade field trip. Mrs. Hambruch, Mrs. Weller, Mr. DerSarkissian, and Mr. O'Sullivan accompanied 43 students to visit national landmarks and experience history of our country.

On Monday, March 25<sup>th</sup> the group departed Barker Central School for

the Gettysburg National Military Park Visitor's Center. The first leg of the trip included a tour of the battlefield, dinner at Dobbin House which was a stop on the Underground Railroad, and the Jennie Wade House. Mary Virginia "Jennie" Wade was the only civilian killed by gunfire during the Battle of Gettysburg.

On Tuesday, March 26<sup>th</sup>, the group, dressed in their Barker Central School District class shirts, boarded their bus and headed to Washington, D.C. where they first toured the White House. Next up were stops at the Washington Monument, Lincoln Memorial, and World War II Memorial. The full day of activity wrapped up with an interactive comedy show, Shear Madness, at the Kennedy Center.

Viewing monuments and memorials continued on Wednesday, March 27<sup>th</sup>. The group would embark on a walking exploration of several key destinations of the National Mall. A tour at the Holocaust Museum offered a unique experience for the Barker contingent as they were greeted by BCS 2002 graduate Christopher Wayner who donated tickets for everyone on the trip. Mr. Wayner presented to the students why the Holocaust was such an important part of history and why it should never be forgotten. As the students continued their journey, they were able to take in the beauty of the cherry blossoms around the Tidal Basin. The day also included stops at the Korean War Memorial, Vietnam Veterans Memorial, Jefferson Memorial, and the Martin Luther King, Jr. Memorial before attending an NBA game between the Washington Wizards and Brooklyn Nets. The Nets won an exciting game in overtime by a score of 122-119.

The final day of the trip on Thursday, March 28<sup>th</sup> began with a stop at the National Cemetery in Arlington, Virginia where the group took a walking tour to view the Tomb of the Unknown Soldier, President John F. Kennedy's Memorial Grave, President William Howard Taft's Memorial Grave, Arlington House to see the Robert E. Lee Memorial, and then the Military Women's Memorial.








# THE SPORTS PAGE








# FROM THE SHELVES OF THE BARKER PUBLIC LIBRARY

Hello from the Barker Public Library!

If you haven't heard, our brand new, big, wonderful Barker Public Library is almost open and ready for business! It has been a five year struggle to continue to provide services to all of you from our small space on Church Street (which we have been grateful for!) and to raise enough funds to make this new build happen. The Village of Barker and the Barker Public Library came to an agreement to make this dream become a reality. Through the generous donations of great people, the hard work of our director, the support of our Nioga



Library System and our local legislators, we were fortunate enough to raise \$728,000 to provide almost half of the funds necessary to complete the project. In addition, together we were able to secure a joint NYS grant for \$400,000. We are so very excited to add to our current services and programming as we grow in our new facility.

In 2014 you voted to allow us to become a School District Library and to be funded by your tax dollars. That year we received \$75,000 from you to run our library. Our current tax levy, 10 years later, is \$82,806, The current budget is about \$98,000. We use small grants, donations and a small amount of savings to balance. The library board has worked very hard to keep spending down. Increasing costs for materials, programs, services, utilities and minimum wage has caused us to request an increase.

So this year we are asking you to support our annual budget with an increase of 9% which will bring us \$90,259. The average taxpayer, \$100,000 in assessed value, will see an increase of \$3.00 for the Barker Library tax!

Please stop in to see us! We don't just have books! The library has DVDs, periodicals, audio books and tablets. We have toddler story hour, book club and summer reading program. Our services are multiplied by being part of the Nioga system; Interlibrary loan, as well as Hoopla and Libby that provide free downloads of ebooks, music and video to your devices! There are computer stations for your use and a child friendly station as well.

Looking forward, we want to provide so much more in the way of programs and events for our community. We can do this with your support. A new Friends of the Library group has formed and they would love to have you join. Through these joint efforts, we feel our library can become a vibrant community center.

Community Ed is working towards moving to an online platform for its registration and payment processing starting with the Fall semester!



Registrants who choose to store their credit card for re-use are protected by Stripe's on-disk AES-256 encryption. Stripe is a Level 1 PCI DSS Compliant service provider.

As up to date class information is important, the instructors and the Community Ed director will be able to communicate with the participants through email in a timely manner.
